## Participant Declaration

*The purpose of this declaration is to insure, that all participants reflect upon their own role and responsibility in connection with the project. The purpose is furthermore to ensure that each individual participant has reflected upon the nature of the programme, their learning needs and their possibility to implement the learning in their daily life.*

**In connection with the activity I have applied for, I declare that:**

### **Art. 1 Project and my role**

1.1. I am aware of the nature of the programme and the project.

1.2. I am aware that the project is a real-life experience where it's going to be my responsibility to participate actively to all training sessions.

1.3. I am aware of the process through which the groups will be formed.

1.3. I am aware of the projects aim and specific objectives, its relevance to myself and my responsibility to ensure a long-term impact.

1.4. I am aware that the project is not academic and will not make me an expert in the subject. I understand that the project is based on non-formal education and that the methods applied by the youth leaders/facilitators are mainly, but not exclusively, interactive.

1.5. I understand that I have responsibility to disseminate the results of the event. I will agree with the youth leaders/organisers what dissemination I will conduct. The dissemination can be an article on the homepage of my organisation, a blog or a workshop for other members of my local community. I understand that pictures or videos involving my person might be used as a dissemination tool.

1.6. I understand that any kind of illegal and/or dangerous behaviour I might engage will lead to my immediate exclusion from the project and repatriation on my own expenses.

### **Art. 2 Programme and activities**

2.1. I have read the activity programme and infopack carefully.

- 2.2. I understand that the programme proposed is subject to changes and improvements.
- 2.3. I am aware that I have a responsibility to contribute to the discussions and interactions throughout the activities. I commit myself to contribute with my experience and knowledge to all activities.
- 2.4. If I have knowledge or experience related to the theme of the activity, I shall inform the organisers and offer my inputs.
- 2.5. I am aware that not all activities in the programme might be relevant for me. I understand that other participants might have other needs than I.
- 2.6. I am aware that I am expected to be present for all the activities of the programme, except for those that are clearly marked as optional/voluntary.
- 2.7. If I have other activities that conflict with the programme (such as an urgent Skype-meeting), absence can be permitted only by the youth leaders/organisers if discussed in advance. I understand that youth leaders might refuse such a request due to the flow of the programme.
- 2.8. I understand that I am expected to be punctual for all activities.

### **Art. 3 Travel**

- 3.1. I am aware that under no circumstances am I allowed to arrive later than the arrival day and depart earlier than the departure day.
- 3.2. I am aware that the organisers expect that I have organised my travel according to what written in the infopack. Infopack is a legal document and participants have to organize their travel according to what written in it.
- 3.3. I can depart early on departure day but not on the last activity day.
- 3.4. I am expected to find my own way to the accommodation.
- 3.5. The budget the European Commission offers for travel is meant as a contribution. I expect that I might have to contribute to this.

## **Art. 4 At the activity venue and accommodation**

4.1. I am aware that it's my responsibility to take care of the accommodation and do not break anything in my room. Any damages caused in my room will be deducted from my personal travel reimbursement.

4.2. I am aware that it's my responsibility to take care of the food and any special diet I might have to follow.

4.3. I agree to comply with the rules set by the organisers and the venue. In particular, I agree with the strict drug policy and the anti-discrimination/bullying policy of the organisers.

4.4. I agree to comply with the rules set by the landlord and the accommodation.

4.5. I understand and agree that failure to comply with the rules might lead to expulsion from the project. I understand and accept that in case of expulsion all cost will be covered by myself.

4.6. I understand that the budget provided by the donor is limited and that the standard of food and accommodation is mirroring the budget. I understand that on these kind of projects I will typically be expected to share a room with more people.

## **Art. 5 Travel documents and reimbursement**

5.1. I understand that my sending organisation will instruct me on how to proceed in relation to travel documents and reimbursement and that not following these instructions might lead to the partial or complete loss of the reimbursement.
